Served in Iraq from June, 2003 to May, 2004. Served as the Acting Minister of Health from June, 2003-September, 2004. The

Ministry of Health has 120,000 employees, 240 hospitals, 1200 preventive health clinics and provides all public health and forensic services to Iraq. 95% of Iraq's 26 million citizens receive health care from the Ministry.

Primary duties were providing leadership/direction/support/consultation in the reconstruction of health care in Iraq and setting a strategic process and health system in place with new leadership, values, strategic vision and plan. Also involved with developing the budget, assessment of hospitals, clinics and equipment, reorganization of the ministry, the strategic planning process, liaison with other senior advisors within the Coalition Provisional Authority and the leadership of CJTF-7 (military). Supervised a senior advisor's staff of 35 from coalition countries including civilians and military. In addition served as the Coalition Provisional Authority's representative along with Iraqi leadership to the World Bank, United Nations, European Union, USAID, other governmental agencies, NGO's and donor countries including drafting and liaising with the funds for health from the United States Supplemental. Engaged extensively with the international media.

The Ministry of Health was the first ministry to successfully transfer to full Iraqi authority. Appointed by Ambassador Bremer to Chair for the Coalition Provisional Authority in partnership with the Iraq Governing Council the annual pilgrimage of Iraqi citizens to the Hajj in Saudi Arabia. Was a Department of Defense Employee liaising with the Office of the Undersecretary of Health Affairs within the Office of the Secretary of Defense.

In April, 1996, the Department of Community Health was established by Governor John Engler combining the Departments of Mental Health and Public Health. In addition, the Medical Services Administration (Medicaid) division of the Michigan Family Independence Agency became part of the new department as well as the Michigan Drug Control Policy office. Recently, the Office of Services to the Aging became part of the Department of Community Health along with the Crime Victims Services Commission.

The Michigan Department of Community Health has a budget of \$9.2 billion. The department has 4,889 employees, and directs and purchases health care for low income and vulnerable persons such as the elderly and disabled, mentally ill, developmentally disabled, substance abusers, and high health-need children. The department contracts with private and public providers to deliver needed services. Responsibilities include overseeing all functions related to re-engineering, quality management, bio-terrorism, administration, budgeting, financial management, policy, legislation, planning and personnel issues. This position reports to Governor Engler and is a cabinet level position.
